The Local 2/Hospitality Industry Child & Elder Care Plan is pleased to announce our annual Application Time— July 1st through the 11th. Through the Plan, parents may receive financial reimbursement for **child care** and **youth** programs. Teens and their parents can participate in **High School & Beyond** workshops. Parents with students in **11th or 12th** grade can apply for college preparation courses for the **SAT/ACT** test. For those with **elderly or disabled relatives**, the Plan offers financial reimbursement for caregiving in addition to personalized counseling and referrals to providers and services.

You will increase your chance of getting the benefit you want if you bring us your application during Application Time in July. In order to participate, you or **a person you designate**, must bring in a **completed** application, as well as the required forms and documentation.

APPLICATION TIPS:

- ▶ **Informal Child Care and Elder Care applicants:** You must bring **proof of residence** for your child or relative **every year**.
- ▶ The forms you bring must be in **English**, otherwise have them translated and verified by a notary public.
- ▶ Bring **copies** of all forms you will leave with us.
- ▶ Check the enclosed brochure so that you submit the right forms with your application.

APPLYING FOR ELDER/ DISABLED CARE?

NEW! This year you can **complete** your application process **during the pre-application sessions**. This means if you bring **all** the required paperwork for your relative, you will **not need to return in July**. Please check our website or the Plan brochure for specifics on paperwork.
